Subject: Lift Industry Wage Settlement Agreement 1 July 2023 - 30 June 2024

Dear Members

At the MANCO meeting held on 05 September 2023 the delegates considered the adoption of the Lift Industry Wage Settlement Agreement for the Metal Industries as an agreement of the MEIBC. The adoption of the agreement was limited to a Section 31 vote and upon reaching the required majority the agreement will only bind parties to the agreement from 01 July 2023 to 30 June 2024.

Prior to putting the question to the delegates, the Vice President embarked upon a process to ensure parity is observed. It was established that the delegates on Employer's side eligible to vote were 11 and on the Labour's side were 9. Both CEO and NEASA agreed to reduce their number of eligible votes by one each.

To give effect to the parity principle required by the MEIBC Constitution the individual eligible votes was recorded as follows: PCASA, LEIA, NEASA (4), KZNEIA, CEO and CEA.

The Vice President requested that the Employer representatives eligible to vote to raise their hand when voting in favour of the adoption of the Lift Industry Wage Settlement Agreement.

The Employer Organisations voting on behalf of - PCASA (Johan Pieterse), LEIA (Lucio Trentini), NEASA (Grant Hermann, Gerrit Fyver, Lianne Viljoen, Joanne Williams), KZNEIA (Kylie Griffin), CEO (Jaundre Kruger) and CEA (Anthony Boy) voted in favour of the adoption of the Lift Industry Wage Settlement Agreement. None of the delegates who are eligible to vote abstained.

The Vice President requested that the Trade Union representatives who are eligible to vote to raise their hands when voting in favour of the adoption of the Lift Industry Wage Settlement Agreement.

To give effect to the parity principle required by the MEIBC Constitution the individual eligible votes were recorded as follows: NUMSA (4), Solidarity, UASA, MEWUSA, NUM and SAEWA.

The Trade Unions voting on behalf of - NUMSA (Victor Radebe, Pholo Sebotsa, Tshepo Mokhele, Henry Myende), Solidarity (Jannem Goussard), UASA (Rick Grobler), MEWUSA (Peter Madigoe), NUM (Mawonga Madolo) and SAEWA (Trevor Lejoane) voted in favour of the adoption of the Lift Industry Wage Settlement Agreement.

The Parties **ADOPTED** the Lift Industry Wage Settlement Agreement concluded in the Metal and Engineering Industries Bargaining Council in terms of clause 10(3) of the MEIBC constitution which bind parties to the agreement from 01 July 2023 to 30 June 2024.
